
Annex A: Curriculum for new Politics, Law and Economics academic major

The Bachelor of Social Science's Politics, Law and Economics (PLE) major consists of 36 course units, a 12-week internship programme, an 80-hour community service commitment, and a series of 7 Finishing Touch workshops. All areas of the requirements are pursued simultaneously throughout the four years.

Senior Thesis (2 CUs)

Eligible students may choose to do a senior thesis in place of two major elective courses.

Study Mission (1 CU)

Students may choose to do either a Law Study Mission or a Political Science Study Mission in place of one major elective course.

MAJOR RELATED OPTIONS (5 COURSES)

Students can use these options to take major courses from other programmes.

CAPSTONE SEMINAR (1 COURSE)

INTERNSHIP (10-week attachment)

Students are required to undertake a minimum of one 10-week internship as part of the process of learning through experience. Within this program, PLE students shall purposefully extend their academic learning by applying and securing an internship with a participating host organisation.

The student will be given work assignments that would be of relevance to both the host and the student's course of studies, in an environment involving on-site work supervision with clear duties with attainment objectives, mentoring/teaching work relationships encouraged, and with a formal evaluation/assessment of the intern's performance.
