Programmes and grants offered by SMU's Institute of Innovation and Entrepreneurship (IIE) for changemakers and budding entrepreneurs

Started in 2009, **Business Innovations Generator (BIG)** is an intensive four-month, equity-free programme offering early-stage start-ups and student founders the opportunity to validate their business plans, refine their products and prep for seed investments. Being founder-centric, BIG supports coachable individuals from within and outside of SMU, from and beyond Singapore's shores, who are interested in entrepreneurship and is committed to developing the SMU and overall Singapore's start-up ecosystem. Founders get to tap into a plethora of support networks, knowledge, and resources, including grant opportunities, world-class mentors and advisors, masterclasses, corporate perks, and access to a conducive workspace located in the heart of SMU in downtown Singapore. 454 start-ups have been incubated by BIG and these start-ups have collectively raised more than S\$613 million funding as of April 2023.

BIG runs two cohorts each year, in January and August. Start-ups from Thailand who have entered the BIG programme included Selfie, which applied research and technology to create a new standard in dental care.

- **Scholarships & Awards for SMU students (eligible to foreign students)**

Awarded to students with prior or current entrepreneurship experience and possess business and technology background:

- The Gary Kunis Scholarship – up to S\$5,000 awarded to eligible SMU undergraduates who are entrepreneurially inclined.
Awarded to students with prior or current entrepreneurship experience and demonstrable financial needs:
- The SMU Entrepreneur Endowed Scholarship – S\$11,250 awarded to eligible SMU undergraduates.
- The Dr. Doreen Tan Endowed Entrepreneur Scholarship – S\$11,250 awarded to eligible female SMU undergraduates (in any degree programme with declared major in Entrepreneurship).
- The Alvin Poh Endowed Scholarship – S\$11,250 awarded to eligible SMU undergraduates.
- The Chan Chong Beng Entrepreneurship Scholarship – S\$12,000 for eligible SMU undergraduates.

Awarded to start-ups with at least one founder affiliated with SMU, who demonstrate promise in terms of growth and development:

- IIE Acceleration Grant – S\$10,000 for eligible start-ups who have been accepted into IIE's Business Innovations Generator incubation programme.
- Startup SG Founder Grant – S\$50,000 for eligible start-ups to first-time entrepreneurs with innovative business concepts and accepted into IIE's Business Innovations Generator incubation programme.

Awarded to students who have their own venture and can commit to work on their ventures full-time for a 10-week period during the months of May to August:

- The Andy Chua and Family Undergraduate Summer Venture Award – S\$1,500 awarded to eligible SMU undergraduates.
- The Kwanpen Postgraduate Summer Venture Award – S\$3,500 awarded to eligible SMU postgraduates and mentorship from industry experts and/or seasoned entrepreneurs.
- The Tolaram Entrepreneurship Venture Award – S\$3,500 awarded to eligible SMU undergraduates and postgraduates and mentorship from industry experts and/or seasoned entrepreneurs.
