Create Transformative Education - Undergraduate

SMU-X curriculum mainstreamed

Following a successful pilot test last year, SMU has now brought its innovative and award-winning SMU-X curriculum into the mainstream. The pilot run, which began in January 2015

with 12 SMU-X courses, was successful with very encouraging feedback. Some 600 students worked in project teams with 56 organisations from the private, public and NGO sectors. Industry partners included DFS and LVMH, Sentosa, and biotechnology firm VRM Biologik. Undergraduates relished the chance to extend their learning beyond hypothetical classroom exercises, while companies profited from the fresh perspectives students and faculty brought to their businesses. Faculty, too, acquired rich data, as well as research ideas and support.

Based on the positive response, SMU added nine new SMU-X courses in January 2016 and will launch six more in August 2016, bringing the total number of SMU-X course offerings to 25 by the end of the year. This will allow as many as 2,000 students to enroll in SMU-X courses – which are cross-listed across different schools – and collaborate with about 100 partners.

Aside from the encouraging response from students, faculty and partners, SMU-X's pedagogical approach to prepare students with future work skills has also received support from the Ministry of Education in the form of a S\$152,000 Tertiary Education Research Fund (TRF) grant. The TRF grant, which was awarded to SMU in November 2015, supports applied educational research on a competitive basis across the institutions of higher learning in Singapore.

The innovative pedagogy has also been lauded by global accreditation body AACSB International as one of the 'Innovations That Inspire'. SMU is the only institution in Singapore, and one of three in Asia to be recognised. Additionally, SMU-X was also shortlisted as a finalist for 'preparing students for the workforce' in the Wharton-QS Stars Reimagine Education Awards held in United States in December 2015.



By 2017, the University aims to provide opportunities for all students to take at least one SMU-X course over the duration of their undergraduate studies.

Other curriculum developments

• SMU has started offering a new academic major in Politics, Law and Economics (PLE) to Bachelor of Social Science students. With its unique combination of disciplines, this highly selective programme is the first of its kind in Singapore. Students will gain a broad understanding of global political and economic transformations, as well as the legal frameworks and contexts within which such changes take place. In addition to the required core courses, students majoring in PLE will choose elective courses from themes such as: **Choice and Behaviour, Global Studies, Public Policy and Governance, and Distribution** and **Justice.** Upon graduation, they will be well-equipped to handle multi-faceted jobs in careers such as journalism, the diplomatic service, foreign affairs and public service, as well as consulting and research, while meeting the challenges of an inter-connected world. SMU received 1,108 applications for the 45 places in the course, which means about 25 students were vying for every place. The demand for the new course also led to a rise in the total number of applications - 14,000 in all this year, a 6 per cent rise over last year.

• Another new major which SMU is offering from this academic year onwards is Entrepreneurship. The major is designed for SMU undergraduates who may be interested in starting businesses or social enterprises, or who want to develop an entrepreneurial mindset, so that they can seize opportunities, innovate and create value in existing organisations. The broad range of modules under the major will give students a rigorous grounding in the tools, techniques, theories, practices and contacts required to identify, refine incubate and grow new business ideas.

Global Summer Programme

Enrolments for SMU's very own Global Summer Programme have increased by 42% as at May 2016, with students coming from schools across 17 countries, and from quality schools ranked in the Top 200 QS rankings, such as Australian National University, Fudan University, London School of Economics, and Cornell University. SMU also launched the SMU Global Exchange Mobile App in Oct 2015, where students (inbound and outbound) can conveniently access information about exchange programmes while on the go. The Office of Global Learning and Integrated Information Technology Services are developing another mobile app that connects the SMU community to give advice on global exchange.

Centre for Social Responsibility (C4SR)

During 2015, 5,683 SMU students were engaged in community service endeavours, with 76.6% participating locally and 23.4% overseas. Locally, SMU students participated in three major summer projects - starringSMU, Inspirar and Kidleidoscope. We reached out to more than 5,000 children, the disabled and elderly from 18 non-profit organisations through these three projects. starringSMU raised a total of \$23,023 through a two-day charity car wash for 'My Buona Vista Place', a centre for social welfare programmes. The team also organised various activities to engage children, youth and elderly from non-profit organisations such as Thye Hua Kwan Moral Welfare Home, SWAMI Home and Kits4Kids. 161 overseas community service projects were organised across 17 countries. Project Namaste X and Project Gazaab Nepal VII returned to Nepal for the tenth year in 2015. In conjunction with the Nepalese Society of Singapore, the teams held a special screening of Himalaya, while also coordinating fundraising efforts to "Contribuild A Home" for those affected by the devastating Nepal earthquake. They raised \$5,028.70 in one week of fundraising, which will go towards building temporary shelters and homes in the worst hit regions of Nepal. Since 2000, SMU students have rendered a total of more than 2.3 million hours of community service. Our last graduating batch contributed an average of 145 hours over their 4 years of study in SMU.

Graduate Employment Survey 2015

Graduates of SMU's undergraduate university programmes achieved higher employment rates and higher incomes than their peers from Singapore's two other autonomous universities, the 2015 Joint Graduate Employment Survey showed. It was the fourth consecutive year in which the three autonomous universities – SMU, NUS and NTU – conducted a joint survey. It revealed that 93.7 per cent of SMU's graduates from the 2015 cohort were employed within six months after completing their final examinations. The average gross monthly salary of SMU graduates in full-time employment was a record \$3,624, higher than any previous SMU cohort. This was an increase over the previous year's average gross monthly salary of \$3,592. Employment for law graduates from SMU also rose to 99 per cent, from 95.6 per cent in 2014. Law graduates remained among the top earners as well – the 2015 cohort earning an average gross monthly salary of \$4,731.

Diversity & Inclusion Updates

The Office of Global Learning has tirelessly spearheaded events and initiatives to drive inter-cultural awareness and appreciation amongst SMU's diverse community of international and local students, staff and faculty members. During the commemoration of SMU's 11th International Peace Day last September, Professor De Meyer unveiled a Peace Pole, which is planted permanently outside the School of Accountancy/School of Law building.

On International Women's Day on 8 March 2016, SMU partnered with the Singapore National Employers Federation for the annual Diversity & Inclusion (D&I) conference, with a focus on women and leadership. It was graced by Guest-of-Honour Mr Teo Ser Luck, Minister of State for Manpower, and His Excellency Mr Scott Wightman, British High Commissioner to Singapore. Specialised practitioners and educators participated in the conference to share and advocate changes on inclusiveness. The event was attended by 300 guests from the public and private sectors, as well as non-government and academia.

Commencement 2016

SMU celebrated its 13th commencement on 13 July, sending 2,663 graduates into the world. Among them are 11 pioneer graduates from the Master of Laws in Cross-Border Business and Finance Law in Asia programme; as well as the University's first law graduate who joined SMU from a polytechnic.

Jubilant family and friends filled the Suntec Singapore Convention and Exhibition Centre to capacity to witness the celebratory event featuring SMU's largest batch of graduates since its inception in the year 2000 as Singapore's first public-funded autonomous university. The event's Guest-of-Honour, Mr Ong Ye Kung, Acting Minster for Education (Higher Education and Skills) and Senior Minister of State, Ministry of Defence, gave the keynote speech to the over 6,000 strong crowd.

Each year, the graduating class raises funds collectively for the Senior Class Gift as a celebration of their SMU journey. This tradition of giving back began when SMU's pioneering class decided that the best legacy they could leave behind was one that could sustain for many generations to come. This year, the Senior Class Gift was enhanced into a meaningful fundraising campaign named 'Bear with us'. Through the sale of the SMU Graduation Bear, a large part of the proceeds will be channeled into the SMU Bursary to support needy students.

Alumni Relations

In support of SMU's Vision 2025 of building an alumni community with lasting ties to SMU, the Office of Alumni Relations (OAR) has continued to foster closer ties with alumni and students. The SMU Industry Night series is a new initiative aimed at providing SMU alumni with a platform to meet their peers from the same industry, and to expand their professional network of contacts. Six industry events have been organised to-date. Other initiatives include: interaction events to connect alumni and students, faculty, staff and senior management with shared experiences or similar interests (such as sports and arts); an alumni business directory launched by SMUpreneurs, which provides a new listing of SMU alumni businesses and tracks 225 firms founded by alumni; the Alumni Career and Professional Development series which aims to equip our alumni with industry and technical knowledge and "soft" skills in line with the focus of lifelong learning through a wide range of seminars, courses and workshops; as well as the Alumni Recognition Ceremony, which recognises special individuals who continue to exemplify the SMU spirit.

OAR also revamped its e-newsletter, SMU Circle, and launched its revamped alumni website in May 2016. New features of the website include current information from live social media feeds and news postings, a university-wide alumni events calendar, and the option for alumni groups to customise their own group pages.

Postgraduate Studies

• For the first time, the Lee Kong Chian School of Business (LKCSB) has made it into the Financial Times (FT) Executive MBA Ranking. LKCSB was the highest-ranked new entrant in the first year of qualifying for the Ranking. Its Executive MBA (EMBA) programme achieved a notable standing of 10th position among Asian institutions, and 36th globally in 2015. • LKCSB has emerged third in the world in the Financial Times (FT) Global Masters in Finance Post-experience Ranking 2016 for its Master of Science in Wealth Management programme. The School remains the only institution in Asia and in Singapore to make it to the top five positions globally, placed just after University of Cambridge's Judge Business School and London Business School.

• SMU LKCSB also ranked 2nd among Asian business schools and 34th in the world in the FT Global Masters in Finance Pre-Experience Ranking 2016 for its Master of Science in Applied Finance programme. MASTER OF SCIENCE IN APPLIED FINANCE ASIAN BUSINESS SCHOOLS ----- AND 34TH WORLDWIDE -----FINANCIAL TIMES GLOBAL MASTERS IN FINANCE PRE-EXPERIENCE 2015 • With a view towards educating legal talents who are well-versed in both Eastern and Western legal systems, who understand both the law and local business culture, and who are able to offer a highly-nuanced service to their multi-national clients, SMU and Queen Mary University of London (QMUL) jointly launched the Dual Masters of Law (LLM) in Commercial Law (Singapore and London) programme in July 2016. Students will first spend six months in Singapore where they will develop a broad overview of Asian commercial law. Thereafter, the programme will take them to QMUL's campus in Holborn, where they will take a series of specialised modules taught by leading commercial law experts.

• SMU School of Information Systems (SIS) and College of Computer Science at Zhejiang University (ZJU) have entered into an agreement for highcalibre ZJU undergraduates to enroll in SMU Master of IT Business (MITB) programme after completing their first 3 years of undergraduate studies at ZJU. This is the first time SIS is partnering a foreign university to offer a fast track programme for MITB students. Upon completion of the SMU-ZJU 3+1.5 Fast-Tracked MITB programme, students will be conferred a Bachelor degree in Engineering from ZJU and a MITB degree from SMU. The first intake will be in Academic Year 2016/2017, where up to 20 students from ZJU will be admitted.

• SMU and the Wealth Management Institute announced significant enhancements to the Master of Science in Wealth Management (MWM). The MWM already covers the whole value chain of processes, products and services related to wealth management. With this enhancement, MWM now also covers industry-defined competencies as spelt out under the IBF standards, such as client acquisition and servicing skills, investment and wealth planning advisory as well as risk controls and monitoring processes. The MWM will now allow participants to also receive the industry certification issued by the Institute of Banking and Finance. The MWM achieves yet another milestone by being the first and only Master's programme to offer training that is accredited against the IBF Standards advanced level for private banking.

Executive Development

SMU's Office of Executive Development (ExD) last year delivered 370 days of executive programmes (of which 62 days were either overseas or off-site) in 8 countries; trained 2,600 executives and achieved a revenue of over \$11.5 million, a 20% growth from 2014.

ExD received high acclaim for the Asia Leaders Programme in Infrastructure Excellence (in partnership with the Economic Development Board). The unique programme is committed to accelerating skill development and building understanding on how major and complex infrastructure projects in dynamic Asia can be made more successful and robust. Adopting practical tools and approaches which will be applied through simulation, case studies and project work, the programme has created new opportunities for collaboration with Harvard University and World Bank Group/International Finance Corporation.

ExD signed a Memorandum of Understanding with the National Trades Union Congress (NTUC) to support the rapid development of executive skills throughout the Singapore economy that NTUC represents. It also held the second Future Ready Forum on 16-17 March 2016 at SMU, inviting participants from various sectors to consider how they could be 'future-ready' – what it means, what the outlook and issues are, and how to prepare for the future. The highlights included a dynamic interactive session with Guest-of-Honour Mr Chan Chun Sing, Secretary-General of NTUC on the topic of "Leaders of Tomorrow", as well as a closing business panel discussion on "Leaders of Purpose" with Mr Tony Tan, CEO of NTUC Link, together with three other panelists.

At the Future Ready Forum 2016, Guest-of-Honour Mr Chan Chun Sing, Secretary-General of NTUC, shared insights on how executives can lead in tomorrow's uncertain world.

Business Development

• As part of building strong global alliances as well as marketing and internationalising the SMU brand, the Business Families Institute (BFI@ SMU) organised and participated in a range of internal and external engagement events with its business family members, the Business Families Alumni Group, and various supporting organisations. In November 2015, BFI conducted two Learning Journeys to Shanghai and San Francisco for BFI@SMU families. In Shanghai, the participants learned about the new developments implemented by the Chinese Government, and gaining insights from family business owners on how they scale their businesses and the challenges they faced.

During their San Francisco trip, they embarked on visits to startups and scaled-up tech firms across different industries, learning how disruptive innovation affects existing markets and discovering relevant opportunities in family businesses.







• The Centre for Professional Studies (CPS) designed and delivered a special programme – Lee Kuan Yew's Style of Leadership and His Ideas on Innovation, exclusively for management staff of Samsung Fire and Marine Insurance (SFMI). In November 2015, SMFI flew in 25 management staff from their South Korea headquarters to SMU for this programme. They were highly engaged in an interactive session including insightful faculty sharing, videos screening and live discussion, which helped the participants gain new management ideas to apply in their organisation.

• The International Trading Institute at SMU (ITI@SMU) has teamed up with IE Singapore, the Singapore Workforce Development Agency and the International Chamber of Commerce Academy to establish the International Trading Professional Conversion Programme (PCP). The International Trading PCP is designed to help mid-career professionals secure employment in middle office roles within the international trade sector and provides a platform for current employees to stay relevant through upskilling, by equipping them with foundation skills and knowledge in areas such as distribution management, risk management and compliance, and quality assurance.

Senior Management Changes: Academic

Professor Pang Hwee Hwa became the Dean of the SMU School of Information Systems (SIS) on 1 July 2016. Prior to joining SMU in 2005, Professor Pang was formerly Division Director and Principal Scientist of the A*Star Institute of Infocomm Research. At SMU, Professor Pang has played a central role in supporting the development and growth of the PhD programmes at the university. He served as PhD Programme Director at SIS from 2006 to 2014, and took on additional responsibilities as Director, and later Dean for Postgraduate Research at the university level from 2011. His strength in research is evident from the more than 20 high-quality papers he has published in top-tier refereed journals, including ACM Transactions of Database Systems, Very Large Database Journal, and IEEE Transactions on Knowledge and Data Engineering.

Professor Pang succeeds Professor Steven Miller, the founding Dean of SIS whose exceptional leadership in the last 13.5 years has built a school that not only has a very strong foundation but is also very highly regarded by academia and industry. Professor Miller will continue with his role as Vice Provost (Research).

Cutting-Edge Research - Research income received in FY15/Inaugural grant wins

Research income received in FY15/Inaugural grant wins

SMU's Schools, Institutes, Centres, Labs and Initiatives (ICLIs) and the Office of Research have rallied in support of SMU's vision to be a premier institution that is internationally recognised for leading-edge research with global impact. The amount of research grants and donations secured by SMU in FY2015 was \$15.5m, of which \$6.1m and \$3.8m were awarded to the Schools and

ICLIs respectively. Research donations totalled \$5.6m. There continues to be broad participation across the Schools, which resulted in the following inaugural grant wins being secured:

• In October 2015, SMU entered into an agreement with DBS to establish the DBS-SMU Life Analytics Lab. An example of how SMU's research has attracted industry funding, the joint lab enables DBS to harness SMU's capabilities in big social data technology and analytics by linking external, publicly available social media information with internal customer information. The Life Analytics Lab at SMU will work closely with DBS' in-house customer data analytics groups and DBS will use the Lab's outputs to create new products and improve the bank's offerings to meet new and changing consumer trends.

Professor Robert Deng





Professor Robert Deng from the School of Information Systems has been appointed as IEEE Fellow effective 1 January 2016. His conferral is recognition of his long history of professional contributions to the field of cybersecurity, and in particular for work on cybersecurity algorithms, protocols and systems.

In December 2015, the team of cybersecurity experts from SMU coordinated by Professor Robert Deng, who is also Director of Secure Mobile Centre, and the UK's University of Surrey won a collaborative grant of two years' funding from Singapore's National Research Foundation (NRF), the UK's Cabinet Office and Engineering and Physical Sciences Research Council to undertake research on human user authentication systems. This inaugural NRF-Engineering and Physical Sciences Research Council (EPSRC) Cybersecurity Joint Grant Call was launched in May 2015 to strengthen collaboration between both countries' best cybersecurity researchers.

• In January 2016, Assistant Professor Hady Lauw from the School of Information Systems was awarded the prestigious Singapore National Research Foundation (NRF) Fellowship. The first SMU faculty member to receive the award, Prof Lauw secured a \$2.7 million research grant from NRF to undertake a 5-year research study on data mining and machine learning. His research involves studying algorithms so as to learn the preferences of consumers from large-scale data of diverse formats and types, which will enable more accurate personalisation for e-commerce applications.

• In the same month, Assistant Professor Chung Siyoung from the Lee Kong Chian School of Business was awarded a grant by the Media Development Authority of Singapore under its Academic Engagement Programme (AEP) for her research project that studies the effects of Singaporeans' media use on civil engagement and communication behaviours. This marks SMU's first award under the programme.

• In November 2015, Associate Professor Gary Pan, who is the Academic Director for SMU-X from the School of Accountancy secured a grant under the Ministry of Education Tertiary Education Research Fund (TERF) to undertake a 2-year research study on the innovative approach of SMU-X Pedagogy in preparing university students with future work skills. The TERF was launched on 30 April 2015 to promote innovation and research into teaching and learning at a higher education level.

School of Accountancy

Associate Professors of Accounting Goh Beng Wee, Jimmy Lee and Lim Chee Yeow are about to publish a paper in The Accounting Review titled "The Effect of Corporate Tax Avoidance on the Cost of Equity". They analyse the effect of tax avoidance on a firm's cost of equity and find that the cost of equity is lower for taxavoiding firms. This effect is stronger for firms with better outside monitoring; firms that are likely to realise higher marginal benefits from tax savings, and firms with higher information quality. Overall, their results suggest that equity investors generally require a lower expected rate of return due to the positive cash flow effects of corporate tax avoidance.

In another forthcoming paper in the Journal of Accounting and Economics, titled "Aggregate Earnings Surprises, Monetary Policy, and Stock Returns", Assistant Professor of Accounting Li Congcong provides evidence that accounting information is useful in predicting the US Central Bank's future monetary policy stance. In particular, the Fed tends to adjust monetary policy by increasing the federal funds rate (i.e., adopt tight monetary policy) following positive aggregate earnings and decreasing the federal funds rate (i.e., adopt loose monetary policy) following negative earnings growth. The findings further suggest that the market reacts negatively to such policy news, which drives the negative aggregate earnings-returns association.



Lee Kong Chian School of Business

Research conducted by Associate Professor Gennaro Bernile - together with colleagues from Cambridge University and University of Oregon - made international news, and was featured in The Economist, and Business Week as well as on regional broadcaster Channel NewsAsia after it was awarded the prestigious IgNobel Prize in Management Studies in the Fall of 2015. Titled "What Doesn't Kill You Will Only Make You More Risk-Loving: Early-Life Disasters and CEO Behavior" the study demonstrates that the risk preferences of CEOs of publicly traded US firms are shaped by childhood experiences with natural disasters. Compared to those without disaster experience, CEOs who experience fatal disasters without extremely negative consequences lead firms more aggressively, whereas CEOs who witness the extreme downside of disasters behave more conservatively. The research also showed the economic impact of the CEO's risk appetite through corporate policies such as capital structure, cash holdings, and acquisition decisions.

Associate Professor of Finance Tu Jun's paper with his co-authors Chin-Han Chiang, Wei Dai, Harrison Hong, and Jianging Fan entitled "When everyone misses on the same side: Debiased earnings surprises and stock returns" won the Best Paper Award in Investments at the 2015 FMA. Commentaries frequently allude to the extent to which earnings missed the consensus forecast (consensus error or CE) as a key rationale for significant stock price movements after earnings announcement, where the consensus is calculated using the mean of the available professional forecasts. The rationale is that the consensus is an unbiased measure of the market's expectation of earnings. However, Associate Professor Tu and his co-authors argued that this rationale is flawed as it is well known that a subset of professional earnings forecasts can sometimes be biased. They proposed a new market surprise measure that is immune to such bias — the fraction of forecasts that miss on the same side (FOM), by ignoring the size of the misses. The FOM measure does a much better job of explaining stock price movements after earnings announcement than the consensus error.



School of Economics

In his paper titled "Optimal international agreement and restriction on domestic efficiency" published in the Journal of International Economics in March 2016, Associate Professor Gea M. Lee developed a multi-country trade agreement model to examine the effectiveness of the World Trade Organization's (WTO) strict treatment of domestic subsidies. The WTO has introduced additional discipline in the use of domestic subsidies that was not present under the General Agreement on Tariffs and Trade, thus raising an important question: is the strengthening of subsidy discipline an efficiency-enhancing regulatory step or has it gone too far? Professor Lee developed a theoretical justification for the world trading system to constrain the use of domestic subsidies for the international objective of expanding market access.

Reflecting his substantive contribution to the analysis of the optimal design of commercial policy in the global economy, Professor Lee has been invited to contribute a survey chapter in the authoritative Elsevier Handbook in Economics series. His survey chapter titled "Subsidies and countervailing duties" is forthcoming in the "Handbook of Commercial Policy" edited by Kyle Bagwell and Robert Staiger.

Assistant Professor Jing Li has published a co-authored paper titled "Cointegration of matched home purchases and rental price indexes - Evidence from Singapore" in a top-field journal, Regional Science and Urban Economics. The paper exploits the homogeneity feature of the Singapore private residential condominium market and constructs matched home purchase price and rental price series using the repeated sales method. These matched series allow the authors to conduct time series analysis to examine the long-term present value relationship in the housing market. One of their findings is that, in the long run, home purchase prices do not significantly deviate from the corresponding rentals. This is consistent with the long-run implications of housing market efficiency.



School of Information Systems

Assistant Professor Pradeep Varankantham was selected by the organisers of the International Joint Conference on Artificial Intelligence (IJCAI) for 2016 to give an Early Career Spotlight Talk. IJCAI is the top event in the world wide community of Artificial Intelligence (AI), and the main international gathering of researchers in AI. It was founded in 1969 for scientific and educational purposes, including dissemination of information on AI at conferences in which cutting-edge scientific results are presented and through dissemination of materials at these meetings in form of Proceedings, books, video recordings, and other educational materials

Assistant Professor Zhu Feida's paper with his co-authors, Wei Chen, Lei Zhao and Xiaofang Zhou, titled "When Peculiarity Makes a Difference: Object Characterisation in Heterogeneous Information Networks", won the Best Paper Award at the 21st International Conference on Database Systems for Advanced Applications. A central task in heterogeneous information networks (HIN) is how to characterise an entity, which underlies a wide range of applications such as similarity search, entity profiling and linkage. Most existing work focus on using the main features common to all. While this approach makes sense in settings where commonality is of primary interest, there are many scenarios as important where uncommon and discriminative features are more useful. To address the problem, a novel model COHIN (Characterise Objects in Heterogeneous Information Networks) was proposed, where each object is Characterise as a set of feature paths that contain both main and discriminative features. In addition, they developed an effective pruning strategy to achieve greater query performance. Extensive experiments on real datasets demonstrate that their proposed model can achieve high performance.



School of Law

A couple of books published in the past year by faculty members from the School of Law highlighted the School's strength in the development and advancement of Singapore law. Even as Singapore law continues to internationalise, the importance of local legal research remains ever so important.

Associate Professor Gary Chan, with contributions from Associate Professor Lee Pey Woan, has written the second edition of "The Law of Torts" in Singapore, based on the highly successful first edition, which had been hailed as a "a pioneering work on Singapore tort law" and cited on multiple occasions by the highest levels of the Singapore courts. Tort law has continued to develop apace in the intervening period since the first edition of the book was published in 2011. Specifically, new torts have emerged, existing torts re-formulated, and important clarifications made by the Singapore courts on the scope of specific torts and doctrines. This book is thus another timely addition to the suite of local textbooks that contribute to the important development of Singapore law.

Associate Professor Gary Chan and Associate Professor (Practice) George Shenoy have also co-edited a new edition of "Ethics and Social Responsibility", with contributions from various faculty members who have taught Ethics and Social Responsibility for several years. The book provides a fresh perspective compared with the numerous books that approach the topic from a Western perspective. In particular, the book deals with issues that are relevant in the Asian context and aims to stimulate critical thought on ethics and



School of Social Sciences

Assistant Professor Hiro Saito's book "The History Problem: The Politics of War Commemoration in East Asia" is forthcoming from the University of Hawaii Press, one of the top presses in Asian studies. In this book, Professor Saito examines why the history problem--Japan's disputes with South Korea and China over the commemoration of the Asia-Pacific War--became so intractable by mobilising relevant insights from sociology, political science, psychology, and philosophy. This uniquely interdisciplinary book offers provocative findings that challenge orthodox explanations and points to a possible resolution of the history problem."

In a recent paper published in the Journal of Personality and Social Psychology, Associate Professor William Tov and SMU Ph.D. student Huey Woon Lee examined how emotions influence judgments of satisfaction and meaning in everyday life. Not surprisingly, satisfying days also tend to be meaningful. However, judgments of meaning were less dependent on emotional experience than judgments of satisfaction. In fact, some negative experiences can enhance meaning even though they lower satisfaction. One key factor seems to be the extent to which the experience has positive implications for one's future. However, the authors suggest that people must distance themselves.





• The **SMU-TA Centre for Excellence in Taxation** held its inaugural conference titled "A New Equilibrium in Tax Competition and Global Tax Co-operation?" on 17 September 2015. The conference was a unique forum for tax specialists, policymakers and academics to discuss key issues on international tax policies and trends with a particular focus on Asia. Senior Minister of State Mrs Josephine Teo graced the event which was attended by over 150 participants from Singapore, Malaysia, Cambodia and other regional countries.

SMU and MasterCard announced in September 2015 the launch of a novel, multi-faceted Social and Financial Inclusion Programme which will catalyse important research on social entrepreneurship and Financial Inclusion. The two-year programme will comprise an annual forum, a seminar series, funding towards student projects, as well as the establishment of the MasterCard Professorship of Social Entrepreneurship and Financial Inclusion. Research outcomes will be presented at an annual MasterCard-SMU Forum on social inclusion and economic value creation. In addition, a seminar series will provide advanced training on the approaches and best practices of social and financial inclusion for senior government officials, central bankers, regulators and senior business executives in the Asia Pacific region and Financial Inclusion. • SMU's **Business Family Institute**, or BFI@SMU, launched a new research report in collaboration with research partner United Overseas Bank Limited on 2 November 2015. Conducted by BFI@SMU between November 2014 and July 2015, the research report titled "Riding on Asia's economic transformation – Growth strategies of Asian business families" revealed that three in five Asian business families view talent recruitment and development as the main challenge to securing the long-term sustainability of their companies. The report also shared insights into how Asian family businesses perceive, build and grow entrepreneurship in family businesses, on top of offering a comparative analysis of entrepreneurial activities as well as succession planning involving professional managers in Asian business families across different countries.

• SMU School of Information Systems (SIS) and Singapore leading's security organisation **Certis Cisco**, through its managed security services provider Quann, have signed a Memorandum of Understanding (MOU) on 21 March 2016 to jointly promote and develop cybersecurity education and research in Singapore among students in tertiary education and cybersecurity professionals. Under the fiveyear partnership, SIS will provide mentorship to trainers of Quann and co-conduct courses by Quann. Selected SIS undergraduates and Master's students will be offered Quann scholarship. SIS undergraduates will also have opportunities to intern at Quann.



• The Lien Centre for Social Innovation (LCSI) released a study on migrant workers in Singapore in November 2015. The study of 801 South Asian migrant workers revealed that 62 per cent of those surveyed with an injury or salary claim with the Ministry of Manpower and 13 per cent of regular workers are likely to suffer from serious mental illness. It also explored the key challenges and psychological distress they faced. Authored by SMU School of Social Sciences Assistant Professor of Sociology Nicholas Harrigan and SMU alumna Koh Chiu Yee, the research identified that the main drivers of emotional distress among workers were the threats of deportation from employers, agent fee debt and lack of housing for workers who have ran away from their employers.





• SMU has set a new record with three awards clinched in the 2015 EFMD Case Writing Competition organised by the European Foundation for Management Development (EFMD). This is the second consecutive year for a multi-award victory – in 2014, SMU broke new grounds for the first and most prizes ever won by a Singaporean educational institution in the established worldwide competition. The winning SMU cases were co-authored by a combination of case writers from the **Case Writing Initiative** (CWI) driven by the SMU **Centre for Management Practice** (CMP), as well as faculty, staff and industry partners.

CMP also started 2016 on a good note – an SMU-written case made it to the Top 15 Bestselling Cases in 2015 at the Case Centre, a renowned international case resource centre for business education. The "Gillette's 'Shave India Movement': Razor Sharp Against the Stubble (A)" case was among 15 top selling cases in the Knowledge, Information and Communications Systems Management category amongst other leading business schools at Harvard, Ivey, IBS and Cambridge. It was co-authored by SMU Lee Kong Chian School of Business Professor of Marketing and Director of the Centre for Marketing Excellence Srinivas K. Reddy, and CMP Senior Case Writer Christopher Dula.

Led by President Professor Arnoud De Meyer, the team explored possible collaborations with relevant Indian institutions and corporations. On 13 April 2016, SMU signed a Memorandum of Understanding (MoU) with BML Munjal University (BMU). Under this collaboration, the universities will work towards establishing joint academic and research programmes. On the same day, SMU, the Confederation of Indian Industry and BMU jointly organised a panel discussion at the Taj Palace in New Delhi, India, to examine the progress of the 'Make in India' programme since its introduction.

A couple of days later, SMU entered an MoU with the Indian School of Business (ISB) to collaborate in the areas of innovation, entrepreneurship and research. The partnership will allow both institutions to explore possible collaboration in Financial Technology research, executive education, as well as retail excellence research. SMU and ISB also organised an industry roundtable to discuss the value of nurturing and managing innovation clusters in India and Singapore. More than 40 participants, comprising government officials, corporate leaders and start-up founders in Telangana state, and ISB faculty attended the session.

SMU signed a Student Exchange Agreement with Universitas Gadjah Mada on 17 December 2015. The five-year agreement allows for the exchange of the equivalent of four semester students per academic year. SMU has also renewed the Student Exchange Agreement with the University of Philippines Diliman for a period of three years. In May 2015, SMU signed a University-level Strategic Framework Partnership Memorandum of Understanding and a University-level Student Exchange Agreement with Shanghai Jiao Tong University and Renmin University, to promote friendly relations through the development of academic collaboration between the two universities, particularly in the areas of social sciences, humanities, economic and management sciences.

On 16 November 2015. SMU hosted the third SMU China Forum 2015 themed "China's Alternative Vision for the World?". Organised for the third year, the forum aims to provide business leaders, policymakers and academics with a platform to facilitate exchange on issues and trends that are shaping China's growth. Last year's opening address was delivered by Guest of Honour Mr Lim Swee Say, Singapore's Minister for Manpower. This was followed by insights from keynote speakers such as Professor Chen Zhimin, Dean, School of International Relations & Public Affairs, Fudan University; Professor Thomas Christiansen, Jean Monnet Professor of European Institutional Politics and Co-Director of the Maastricht Centre for European Governance, Maastricht University; and Mr Jim Lai Chi Ming, Vice President, Tencent Group. The Forum discussed how China and Singapore can contribute to the "One Belt, One Road" and the "Mass Entrepreneurship and Innovation" strategies, which are poised to influence global trade. Held just after Chinese President Xi Jinping's visit to Singapore, the event saw timely discussions and expert views on China-related topics that impact the global economy.

SMU has always been committed to nurturing global perspectives and cross-cultural understanding among our students. Through the International Office, SMU has secured several new student exchange partnerships in 2016, including the University of Edinburgh (United Kingdom); Graduate School of Management, University of St. Petersburg (Russia); National Research University Higher School of Economics (Russia); University of Alberta, Alberta School of Business (Canada); and Erasmus University, School of History, Culture and Communication (The Netherlands). The other new agreements which are in the final stages include The University of Melbourne, Faculty of Business & Economics (Australia) and University of College London, School of Management (United Kingdom).

SMU students will have access to a wide variety of courses such as Financial Management, Financial Accounting, International business, Public Management, Marketing, Arts & Culture Studies, and Humanities & Social Sciences, amongst others.

School of Law Topping-Out

After two years, the much-anticipated SMU School of Law (SOL) building has reached a significant milestone in construction with the completion of the building structure. Commendably, the development has also achieved more than one million safe man-hours. To mark the momentous occasion, SMU held a Topping-Out Ceremony on 13 May 2016 for the new SOL building. The event was well attended by several members of the SMU Board of Trustees; key members of the SMU senior management; SOL faculty and alumni; and staff from various key departments who were involved in the different phases of construction.

The new building will be a distinctive landmark that will contain stateof-the-art facilities used both to enrich the learning experience of SMU law students as well as involve others within the legal fraternity who are important stakeholders of the University. The new 23,000-square-metre building – about the size of 52 basketball courts – will be ready by 2017. A key feature if the new building includes a 2,200-square-metre Law Library which will be fully equipped with modern technology wired for legal research in the 21st century. Also housed within the new building will be the David Marshall Moot Court, the SMU Pro Bono Centre, and other research centres.

Presidential Distinguished Lecturer Series

Five distinguished speakers presented the 20th-24th talks in the Presidential Distinguished Lecturer Series between September 2015 and May 2016. Professor Alessandro Acquisti, Director of the Privacy Economics Experiments Lab at Carnegie Mellon University, shared his views on data privacy and discussed what motivates people to share their personal information online, and the value of privacy in this information age. Mr Jyrki Katainen, Vice-President of the European Commission for Jobs, Growth, Investment and Competitiveness, touched on the links between the European Union and ASEAN on top of sharing the three initiatives which the European Commission has launched to spur investment. Professor Craig Calhoun, Director of the London School of Economics and Political Science, expounded on the intricate relationship between capitalism and externalities and explained the dependence of capitalism on nation states.

Mr Olusegun Obasanjo, former President of Nigeria (1999 – 2007), shared his insights on how Nigeria as the 7th most populous country globally is constantly evolving. He also spoke on the importance of economic integration and creating an identify for Africa. Lastly, Professor Dr Susilo Bambang Yudhoyono, former President of the Republic of Indonesia (2004 – 2014), gave a macro overview of his 10 years in office and shared many insights on his leadership style. Delving deeper, he spoke on the measures he took to overcome challenges which eventually led to the transformation of Indonesia in the areas of democracy, prosperity and national security. All the lectures were followed by an engaging Question and Answer session, where guests posed thought-provoking questions to the speakers.

SMU's Report to the Committee on Future Economy

In response to the call to contribute to the dialogue initiated by the Committee on the Future Economy (CFE), SMU has held a series of engagement sessions with faculty and staff to brainstorm and propose recommendations to add to the government's deliberations on strategies for the next stage of Singapore's economic growth. The SMU engagement sessions discussed future scenarios as well as practical challenges in view of Singapore's existing economic and social structures.

Through the leadership of SMU Provost, Professor Lily Kong, a total of 48 SMU members produced various recommendations on five key areas namely Corporate Capabilities and innovation, Future Growth Industries & Markets, Future of Connectivity, Future City and Future Jobs and Skills. These recommendations were put together in a paper titled "Contributions to the Committee on the Future Economy".

In the same vein as the efforts spearheaded by the CFE, the engagement process at SMU was an inclusive one. An open invitation was made to all faculty and staff who were interested to attend the engagement sessions. Specific SMU members who have deep content knowledge of the five areas (through research, education or practice) were specially invited to participate and contribute their thoughts and expertise. The draft of the paper was shared with SMU's Board of Trustees, whose comments helped to refine and finalise the draft.

Additionally, the report was turned into an electronic flip book, complemented with pictures and graphics. It has now been posted on the homepage of the SMU website.



ST Education Forum 2016

The Straits Times Education Forum returned on 25 June 2016 with SMU as the higher education partner, following the success of the first two events in 2014 and 2015. Themed "The Future of Jobs, Skills and Higher Education", the half-day Forum provided a great opportunity for the participants to obtain the most current insights on the changing landscape of higher education, jobs and skills.

The event's Guest-of-Honour Mr Ong Ke Yung, Acting Minister for Education (Higher Education and Skills), unveiled a pilot co-operative programme during his keynote speech. Under the programme, university students can alternate between the university campus and the company every semester. They can also be hired by the company and get an income throughout their course. Mr Ong noted that this change serves to recognise the increasing need for students to possess both soft skills and deep technical skills for the future economy. He also highlighted the need for universities to be diverse in expertise so they can fulfill their core mission – to impart skills, create and transmit knowledge, as well as to shape and define society.

Besides Acting Minister Ong, the other panellists were SMU President Prof Arnoud De Meyer, Straits Times Senior Education Correspondent Ms Sandra Davie, as well as Straits Times Deputy Director Mr Ignatius low. The Ouestion & Answer segment towards the end of the event saw spirited exchanges emerge between the panellists and participants over issues such as the relevance of university education and how students should be assessed. Weighing in on a question by an SMU student on how university grading can be changed to become more relevant to the industry, Professor De Meyer said that it involves more than just grading students on exam scripts. SMU, for instance, uses peer evaluation within project teams, in which students assess each other based on contribution and capabilities. ST Deputy Editor Ignatius Low, who moderated the panel discussion, also asked Prof De Meyer if it would be possible for students to obtain academic credits for outside work, for instance an in-depth journalistic feature that is published in ST during an internship. He replied that this was something the university could take into consideration - a flexible approach which Mr Ong said was very encouraging.

About 250 people attended the forum at the SMU Mochtar Riady Aduitorium, including educators, students and parents from 21 educational institutions, members of the SMU community, as well as the media and Straits Times readers.

SMU the Exclusive Higher Education Partner for Channel NewsAsia's Perspectives

SMU strengthened its growing reputation in the role of thought leadership when it was for the third time the Exclusive Higher Education Partner for Perspectives – Channel NewsAsia's flagship panel discussion programme dissecting current events and issues. On 7 March 2016, SMU hosted the first of six new episodes of the series at SMU Labs. The discussion, titled "Upskilling ASEAN for Growth" featured an esteemed panel of thought leaders including SMU President Professor Arnoud De Meyer, who talked about the differences in goals and objectives of the ASEAN countries in relation to the ASEAN Economic Community integration. In the second episode, SMU Provost Professor Lily Kong tackled the topic "Urban Challenges in Asia's megacities" and discussed ways to look at problems Asian megacities face and what it will take for these large cities to remain sustainable, liveable and resilient.

Professor David Lee Kuo Chuen, Lee Kong Chian School of Business, honed-in on the topic "The Future of Fintech" and shared his knowledge about the rise of blockchain technology and its potential impact on the existing banking industry; Professor Gerry George, Dean of Lee Kong Chian School of Business, discussed the topic "Scaling up Entrepreneurship: From Startup to Enterprise", including the various aspects to consider in order for people to be more culturally supportive of scaling up entrepreneurship; while Professor Ann Florini, School of Social Sciences, tackled the topic "Climate Change and the Global Economy" and discussed various factors that can propel radical global action to stave off environmental catastrophe and an economic meltdown. In the final episode, SMU Board of Trustees Chairman Mr Ho Kwon Ping and Associate Professor Henry Gao, School of Law, dived into the topic "The Impact of China's Economic Slowdown", leading the audience through a dynamic and multi-faceted discussion of the implications of China's moderating growth for both the region and the world. Teymoor Nabili, a veteran international journalist, moderated debates which drew questions and discussion points from audiences comprising SMU faculty members, students and staff, as well as guests from corporate, political and civil sectors.

8th ASEAN Para-Games

Singapore hosted the 8th ASEAN Para-Games (APG) for the first time from 3 to 9 December 2015, which featured 15 sports for persons with disabilities. Swimmer Yip Pin Xiu (School of Social Sciences), who was Singapore's official flag bearer, did SMU and Singapore proud by clinching gold and breaking the world record at the women's 50m backstroke event. She also bagged silver in the 100m freestyle S5 (S1-S5). It was a performance that epitomised the spirit of the APG and the grit of the 1,000-odd regional competitors who rose above the challenges that life presented to them. Apart from Pin Xiu's outstanding achievements, SMU musicians and emcees also played a part at the APG in support of those with special needs. Nine members from the SMU fraternity literally 'banded together' during the APG. SMU Chinese Orchestra and Associate Dean, SOSS Professor Tan Yoo Guan volunteered their time to be part of the Purple Symphony, Singapore's first all-inclusive orchestra made up of musicians with and without special needs. At the Games' closing ceremony, the musicians performed a repertoire of Asian and Western songs in a celebration of togetherness and musical excellence regardless of physical abilities. Additionally, seven students from SMU Broadcast & Entertainment - a students' club set up to manage SMU Campus Radio and SMU Campus TV - were invited by Sport Singapore to become presenters. Paired with professional sports commentators to give 'live' event coverage, these students underwent an intensive 3-week training programme in the lead-up to the competition.

18th ASEAN University Games

The 18th ASEAN University Games (AUG) was held from 10 to 19 July 2016 in Singapore — the 3rd time since 1994 — and was attended by more than 1,800 athletes and officials from the 10 ASEAN countries, as well as Timor-Leste. 25 SMU students were part of a 240-strong Team Singapore and 12 of them contributed 5 Gold, 1 Silver and 4 Bronze medals (including both individual and team sports) to the overall tally of 24 Golds, 20 Silvers and 29 Bronzes for Singapore.

As part of the Singapore University Sports Council formed with the five other local universities, SMU oversaw five core areas of the Games and two sports – Accreditation; Education; Protocol; PR, Media and Publications; Info-Technology; as well as Badminton and Swimming. About 30 SMU full-time and contract staff from the Office of Student Life and various SMU offices were part of the organising committee. Together, they supervised nearly 100 SMU student volunteers involved in various areas aspects of the Games.

A new initiative spearheaded by SMU, the Education functional area brought together about 150 student athletes on a walking trail through various iconic landmarks around Singapore's civic district and the Sports Hub over two days. In addition, 348 students from nine institutions (JCs, ITEs and secondary schools) also took part in a series of Learning Journeys organised by the Education functional area to understand first-hand how the Games were organised.

Apart from the Games, SMU Eurhythmix put on a media-enhanced, sports-themed hip-hopping show-stunner during its Opening, SMU Sound Foundry jammed at its pyrotechnic-blazing Closing, while SMU Voix, SMU MIC, and SMU Artdicted added a touch of class, colour, and fun to a number of specially-organised athletes' experience activities.

In April this year, our law students clinched the top prize from the Price Media Law Moot Court Competition (Price Moot), becoming the first university to win the competition twice. This was the third that SMU had reached the final of the Price Moot – yet another record in the competition.

Most recently, SMU's mooters did Singapore proud again by taking top position at the 2016 International Criminal Court (ICC) Moot Court Competition. Having also won the moot last year, SMU now has the best track record in this competition, and enters the record books as the first university to successfully defend a championship in a major international moot. The competition is the largest and most prestigious moot competition in the world on international criminal law.

The team's double win brings their haul of treasure to a shelfbending 15 awards over the past two years. SMU was also the only university to receive an award at this year's event.



IITS continued to do SMU proud by being a double winner at CIO 100 Honouree award for the second consecutive year. The projects were: the Service Request and Incident Management System (SRIMS), which helps to improve customer service over time and hardening SMU's security profile by watching incidents and understanding trends, as well as the new SMU intranet portal - iNET. SMU's Chief Information Officer and Vice President for IITs Mr Lau Kai Cheong, received the awards at the CXO-CIO Conference Singapore on 7 April 2016.

Additionally, IITS won the Gold award at the Intranet Innovation Award 2015 by IT Consultancy company StepTwo Designs for its development and deployment of the iNET. SMU is the first university in Asia to receive this prestigious award. Created for the 1,000 faculty and staff at SMU, iNET has been developed to improve operational excellence, and enhance collaboration and knowledge discovery in the university.

Since August 2015, new and existing donors have contributed many noteworthy gifts. Highlights from this past financial year include: SMU Lee Kong Chian School of Business alumni Jeff Tung and Benjamin Twoon's gift of \$1m to establish the P.A.K Entrepreneurship Fund, which encourages entrepreneurship among SMU students; MERCU Learning Point, together with two Singaporean donors, contributed \$600,000 to establish the MERCU-SMU Excellence Scholarship for full-time Malay Singaporean undergraduates at SMU; and a gift from MasterCard to support the MasterCard-SMU Programme Initiative on Social and Financial Inclusion, an original and innovative programme inclusive of a research forum, Professorship of Social Entrepreneurship and Financial Inclusion, and a seminar series.

SMU is off to another good start this financial year (FY2016). Some notable gifts already include Cheung Kong Graduate School of Business' contribution to help launch the ASEAN Business Research Centre at Lee Kong Chian School of Business; Sing Lun Holdings Limited additional donation of \$500,000 to endow the existing Sing Lun Scholarship for needy students; and the Kwan Im Thong Hood Cho Temple's second gift of S\$1 million to support emergency grants, providing one-time off emergency financial assistance to assist SMU undergraduates facing unforeseen financial crises.

Additionally, Dr Tahir, Founder of Indonesia's Mayapada Group, and his son Jonathan Tahir, contributed S\$1 million to establish the Tahir SMU– UGM Management and Faculty Development Programme (MFDP). The objective of the MDFP is for SMU to organise various events and programmes in collaboration with Universitas Gadjah Mada (UGM) towards building academic excellence, as well as creating new opportunities for innovation and co-operation. In addition to the gift agreement, SMU President Professor Arnoud De Meyer also signed a Memorandum of Understanding (MOU) with representatives from UGM. The MOU entails faculty exchange and development, research initiatives, sharing of best practices in university governance, and exchange of undergraduate and postgraduate students.
